About the Market



Location and Time

1. The market is every Saturday morning between 9:00am and 12.30pm, rain or shine at

Heritage Square, 2 George Street, Timaru.

2. The Market is open for Stallholder set-up from **7:45am until 8:45am** each Market day. Stallholders are required to fully set up their stall prior to commencement of trade.

3. As per **Timaru District Council Rules NO** vehicles are permitted on the Market site.

4. Trailers and Caravans are allowed on site but as not vehicles are allowed on site they must be pushed in place. Access is at the chained entrance at the far end of the market.

5. Smoking is not permitted within the Market area.

Food Handling and Health & Safety

6. Stallholders must comply with Timaru District Council and Ministry of Primary Industries and other regulatory body regulations.

8. All foods, other than fresh unprocessed produce, must be prepared in a registered kitchen.

Site Allocation and Use

9. Each stallholder will be allocated a 3x3m site and must operate within the boundaries of their allocated site. Should a Stallholder require more room they must tell the Co-ordinator prior to the 5pm Thursday.

10. The site must be left in a clean condition as that in which it was found.

11. The stallholder must set up in accordance with the official weekly site plan and as directed by the Co-ordinator.

12. The Stallholder must not pack up or leave the site before 12.30pm unless agreed to by the Co-ordinator.

13. Stallholders should display clearly the name of their business.

14. Any produce labelled as “Organic” must be certified by a recognised New Zealand Organic Association such asASUREQuality, Bio-Gro, Certenz, OFNZ.

15. Stallholders must provide their own Tables, Equipment, Umbrellas or Gazebos

Stallholder Vehicle Parking

16. There is limited vehicle parking for loading and unloading, please be patient.

17. Stallholder vehicles must be parked away from the close parks near the market as these will be used by our shoppers. There is free parking at the car park at the end of Station Street in the Des Seagar Car Park.

Fees and Payment

18. Site fees are paid each week in cash to the Co-ordinator at the Market, or by internet banking no later than the Thursday 5pm preceding the Market.

19. The Operator retains the right to alter fees at any time with reasonable prior notice in writing to all vendors.

Rubbish & Site

20. The Stallholder must dispose of their own rubbish and waste off-site in accordance with sustainable business practices. (Not in public rubbish bins nearby).

Insurance

21. Insurance cover for loss or damage to Stallholder goods or property on site is the full responsibility of the Stallholder. We advise Stallholders to consider Public Liability Insurance. The Timaru Artisan Farmers Market will not accept responsibility for loss or damage to goods, property and vehicles of participating Stallholders.

22. The Stallholder is required to ensure all property and equipment is properly anchored in the interests of public, vendor and staff safety. Use of tie downs is recommended to secure gazebo. Operator accepts no responsibility for damage or injury to the Stallholder or public.

General Conditions

All Stallholders acknowledge that the Operator will make Stallholders' names and contact details available for interested parties from time to time for business promotional purposes and all Stallholders grant permission for the Operator to use any images or photographs of Stallholders' stalls and Stallholders for promotional purposes.
